Process of applying for APEC Funds

1. Concept Note Stage: understand scoring framework.

a) **Internal Submission Deadline**: the CN must have for a endorsement, co-sponsors, in compliance with Guidebook.

b) **Final Submission Deadline**: the CNs are assessed against the specific eligibility requirements.

There are more CN applications than there is funding available, thus, not all Projects are funded. Through Scoring Process, CNs are assessed against the specific eligibility requirements of the funding source and then scored. Those CNs with higher scores will be funded and approved 'in-principle' by BMC.

2. Project Proposal Stage

a) PMU assesses according to the Quality Criteria :

Relevance, impact, effectiveness, sustainability and efficiency.

b) The Secretariat provides assistance until it meets the satisfactory quality on all criteria, then the PP is recommended to the BMC for approval.

Concept Note stage

- **21 March:** Internal Submission Deadline (submit to Program Director)
- **28 March:** Final Submission Deadline (submit to Project Management Unit)
- **3-17 April:** Responsible APEC Fora to assess eligibility and score concept notes
- **23-26 April:** BMC In-Principle Approval
- **27 April:** Project Overseers to be notified

Project Proposal stage

- **25 May:** Submission of Project Proposal to APEC Secretariat



PROJECT UPDATES

Key Information

- The **Guidebook on APEC Projects** is updated every year, usually around October. Please monitor the APEC website for the revised edition. You will find guidance in relation to changed project processes on the APEC website.
- Ensure you are using **the latest version of all templates** as published on the APEC website, especially the Concept Note (which may be reviewed as part of the Guidebook, see above).
- Monitor the **eligibility criteria and fund priorities** specific to the fund that you are interested in. The GPA fund priorities are reviewed annually in December.
- When developing your Concept Note, refer to the **APEC Scoring Template** to understand how your concept will be scored.
- When requesting to **amend the design or budget** of a project (including extension requests) , use the APEC Project Design Amendment & Extension form and the APEC Project Budget Amendment form.



Sources of funding for APEC projects

- **General Project Account (GPA)**, mandatory annual economies contributions. Supports all types of APEC projects.
- **Trade and Investment Liberalization and Facilitation Account (TILF)**, voluntary contributions. Projects must contribute to trade and investment liberalization and facilitation and require to self-fund a percentage.
- **APEC Support Fund (ASF)**, voluntary contributions. Projects must address the capacity-building needs for APEC developing economies.
 - **ASF** has **11 Sub-funds** that must address capacity-building in their own specific way.



PROJECT UPDATES

Key Information

- **Monitoring Reports (MRs)** are due on 1 February and 1 August EXCEPT for projects approved in 2018 and onwards. 2018 projects are due once-yearly on the date advised to POs in the Letter of Acceptance (either 1 April or 1 October).
- **Completion Reports (CRs)** are due within 2 months of the end of a project. Penalties apply for late submission of MRs and CRs:

Failure to submit MRs or CRs:

- POs with outstanding MRs are ineligible to submit new CN or have PPs approved until overdue reports are submitted.
- Any APEC forum whose project has not submitted a CR is ineligible to submit new Concept Notes or have any full proposal approved until all overdue reports are submitted.



KEY ADVICE FOR PROJECT IMPLEMENTATION

How to have a successful workshop:

- Give sufficient notice to members of workshops, nomination requests (strongly recommended two months notice before the events).
- Do your research and use your networks to find the right participants and speakers (don't rely on members to find them for you).
- Involve relevant International Experts and organizations as speakers, ensuring you follow the Guidelines on Managing Cooperation With Non-members.
- Invite a representative(s) of other APEC working groups if relevant.
- Work closely with your Secretariat Program Executive on travelers approvals and acquittals.



KEY ADVICE FOR PROJECT IMPLEMENTATION

Be familiar with and follow APEC procurement rules:

- **Guidebook Chapter 12** on Contracting
- **Procurement takes time!** Refer to your Letter of Acceptance for suggested timelines.
- Different requirements for contracts below USD 5,000; 20,000; 50,000; 50,001 and above.
- When evaluating bids, ensure that the specific Evaluation Criteria identified in the Request For Proposal (RFP) documentation are used to evaluate the bids.
- For over USD 50,001 get your proposal assessment panel together early. Only members of your forum officials (or their nominated delegates) can be assessors.
- Use the RFP timeline and correct templates

SELF-FUNDED APEC PROJECTS

- Can be put forward at any time
- Must be approved by the group
- Must comply with **APEC guidelines and practices** (hosting, publications, logo use, non-member participation)
- Project Overseer must submit **Self-Funded Project Proposal Coversheet** (Guidebook on APEC Projects, Appendix C) to the Secretariat before commencement of the project
- Project Overseer is strongly encouraged to submit **Completion Report** (Guidebook on APEC Projects, Appendix G)
